## Participant Agreement, Release, and Acknowledgment of Risk

In consideration of the services of the Run for the Unborn, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in capacity on their behalf (hereinafter collectively referred to as "race personnel" I hereby agree to release and discharge race personnel on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that Run for the Unborn entail known and unanticipated risks which could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.
2. **The risks include, among other things:** collision with other participants, the walls or fixed objects; falling down; my own equipment failure or failure of other's equipment; my own or other's negligence; objects or conditions on the course surface that may cause me to fall; broken bones, sprains; head, neck and back injuries; abrasions; and bruises.
3. Furthermore, Race employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.
4. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks.
5. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless race personnel from any and all claims, demands, or causes of action, which are in anyway connected with my participation in this activity or my use of race's equipment or facilities, **including such Claims which allege negligent acts or omissions of race personnel.**
6. Should race personnel or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold harmless for all such fees and costs.
7. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of -all risks that may be created, directly or indirectly, by any such condition.
8. In the event that I file a law suit against race personnel, I agree to do so solely in the state of Wisconsin, and I further agree that the substantive law of that state shall apply in this action without regard to the conflict of law rules of that state.
9. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect.

**By signing this document, I agree that if anyone hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against race personnel on the basis of any claim from which I have released them herein.**
